## **Health Information**

## Educational Information

The sources of drinking water, both tap water and bottled water, include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally- occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff and septic systems.
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water, which shall provide the same protection for public health.

### Additional Health Information

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not your drinking water meets health standards. During the compliance period noted in the above table, we did not complete all monitoring or testing for the contaminant(s) noted, and therefore cannot be sure of the quality of your drinking water during that time.

### Actions Taken

A non compliance was issued following all protocol and regulations, the late date was not my fault. Water was sampled at 3:05 pm on 10/26/2022 and mailed priority overnight mail (USPS), the samples were held in Madison and delivered 10/28/2022 (this information was verified by the New Glarus Post Office). My name and phone number was on the paperwork. I checked emails 10/27/2022 and 11/1/2022, I was off 10/31/2022. No phone call, but an email on 10/28/2022 opened on 11/1/2022. I spoke with the Director at State Lab of Hygiene in Madison, he said no phone calls are made because of computer generated emails. I asked why even put my phone number on paperwork accompanying sample? The Director didn't have an answer. USPS refunded the priority overnight postage and apologized for the error.
